

Treaty of Versailles Bubble Activity

Objective: Students will be able to visually display the key components to the Treaty of Versailles and state why such ideas were **DESIRED** and **INCLUDED** as well as the **CONSEQUENCES** of the ideas inclusion.

You will be visually illustrating the causes and consequences of the Treaty of Versailles on post-war Europe - lets begin linking to World War II. Working in groups of **NO MORE** than **3** use the letters of the Treaty of Versailles to visually display the key components of the treaty.

FIRST:

30 Points – 10 points for including 10 specific provisions (1 pt each) & 20 points for accuracy (2 pts each) – creativity & critical thinking included in points

1. Use **LETTERS** to write out **VERSAILLES TREATY**
 - a. Turn the letters into images that represent 10 specific and different provisions associated with the Treaty of Versailles - they must be accurate and related to the peace plan!
 - i. These provisions should include the following - be creative and think critically:
 1. Specific provisions - what it stated (5)
 2. Causes for provisions - why a provision was included (2)
 3. Consequences of provisions/future events (3)
 - ii. How to achieve 10 provisions by altering letters:
 1. You will have 1 set of THREE letters connected
 2. You will have 4 sets of TWO letters connected
 3. You will have 5 SINGLE letters
 - iii. You may only use a component **ONCE** in your visual (i.e. Once you use League of Nations you cannot use that idea again)
 2. Color the pictures so that they are more easily identifiable

SECOND:

30 points – 3 points per provision

1. On a separate sheet of paper (to be attached to your drawing) write each letter/group of letters and how it has been altered to represent a component of the plan.
 - a. Include the following in your explanation for each provision:
 - i. Specific Provisions
 1. Why was the provision included in the Treaty of Versailles
 2. What was the consequence of the provisions inclusion in the Treaty of Versailles
 3. How does your alteration represent the provision
 - a. What from the treaty is the letter(s) illustrating? Explain your symbolism
 - ii. Causes for Provisions
 1. What provision(s) did the causes lead to being included in the Treaty of Versailles
 2. What was the consequence of the provisions inclusion in the Treaty of Versailles
 3. How does your alteration represent the provision
 - a. What from the treaty is the letter(s) illustrating? Explain your symbolism
 - iii. Consequences for Provisions
 1. What provision(s) did this result from in the Treaty of Versailles
 2. How does your alteration represent the provision
 - a. What from the treaty is the letter(s) illustrating? Explain your symbolism

Explanations *Each provision included is worth 3 points based upon this rubric.	The explanation shows that the content is understood by summarizing concepts & provides thorough analysis of the provisions causes and consequences with specific examples for support and depth.	The explanation has limited content knowledge or analysis of the provision; larger concept connections or specific examples for support are missing when discussing the causes and consequences.	The explanation fails to analyze the provision with all required elements. Either the cause or consequences is missing in the explanation.	The explanation fails to summarize the provision correctly or explain the causes and consequences.
